

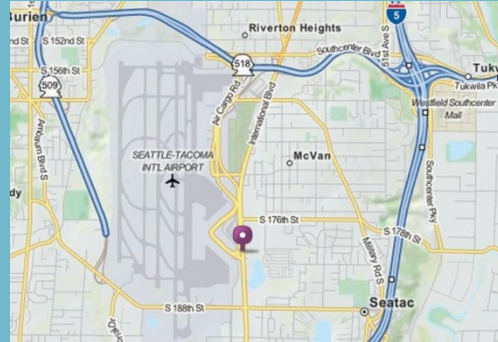
PEACE OF MIND AND CONTROL

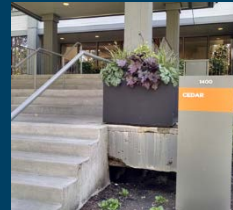
