Mark is a member of the South and East King County Estate Planning Councils. Mark focuses his practice on Probate, Estate Planning, and Business Formations Law.

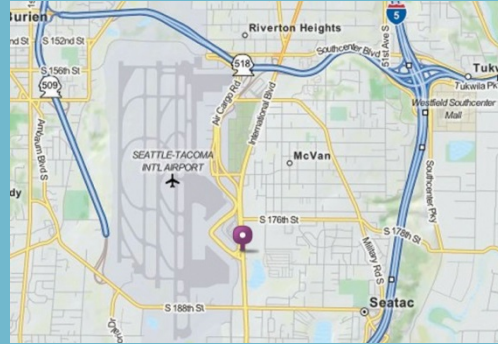

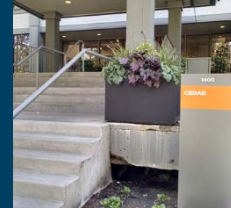

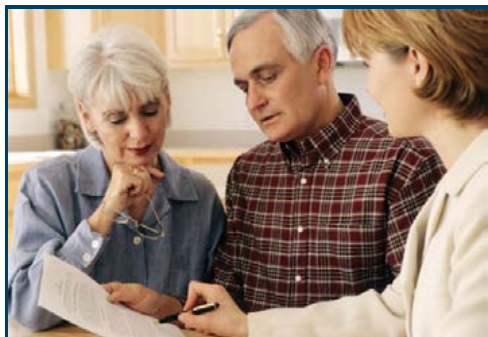
